

GENERAL TERMS AND CONDITIONS

Definitions

K.I.T. Group GmbH is the Professional Congress Organiser (PCO) of the World Confederation for Physical Therapy Congress 2019, held 10 – 13 May in Geneva, Switzerland.

The PCO leads the registration services, hotel accommodation and is hereinafter referred to as K.I.T. Group.

Terms and Conditions for Hotel Bookings Reservation

Terms and Conditions for Hotel Bookings Reservation

Hotel accommodation is subject to availability and will be allocated on a first come, first served basis.

All rates listed are per room and night in CHF (Sfr) and include VAT and breakfast.

Telephone reservations will not be accepted. All reservations must be made using the official booking form.

Should the selected hotels be sold out, K.I.T. Group reserves the right to book a hotel in a similar category and price range. Should you plan to arrive at your hotel after 18.00 please inform K.I.T. Group accordingly.

Please contact K.I.T. Group at wcpt2019@kit-group.org for bookings of 10 rooms or more, as they will be handled separately.

Payment

Accommodation will be allocated upon receipt of the hotel booking request together with the credit card details, and your card will be charged with a deposit of 40 CHF.

The remaining amount due for the entire accommodation costs will be charged on 4 February 2019, and K.I.T. Group will then send out an accommodation invoice.

Alternatively, a bank transfer for the entire amount can be made by this date. Please indicate "WCPT 2019", your name and participant number on all payments.

All costs and bank fees must be paid by the transmitter. Please indicate "FREE OF CHARGE FOR RECEIVER ACCOUNT" on all payments. If the payment is not received in FULL (free of bank transfer fees) the payment cannot be confirmed.

From 4 February 2019, only credit card payments will be accepted, and the provided credit card will be debited upon receipt of the booking.

Should K.I.T. Group not receive the payment on time or not be able to debit the provided credit card on 4 February 2019, the hotel reservation will be cancelled in accordance with the cancellation conditions.

Confirmation and Invoice

Confirmation of the hotel booking will be sent out upon receipt of the housing request.

Changes and Cancellations

All changes and cancellations must be sent in writing (fax, letter or email) to K.I.T. Group.

Please note that hotels will not accept any changes or cancellations directly.

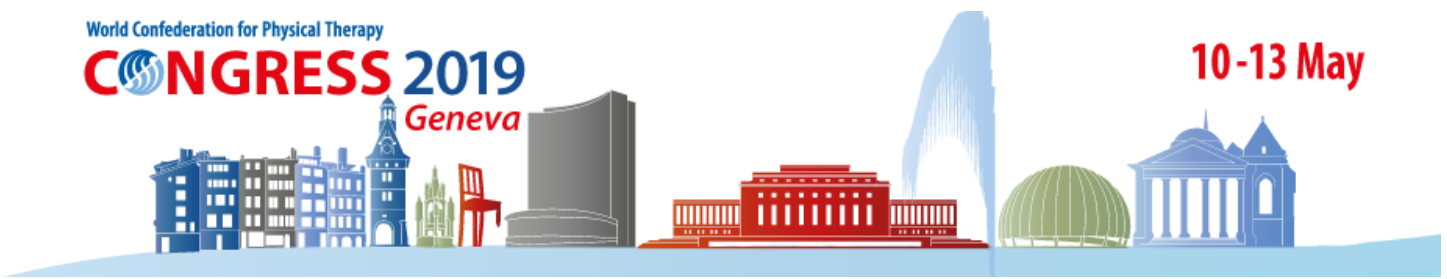
K.I.T. Group will retain the deposit of 40 CHF for cancellations received before 4 February 2019. For cancellations received after 4 February 2019, no refunds will be possible. After this date, the full value of the reservation indicated on the hotel reservation form will be charged.

For a reduction in the length of stay or in the case of a no-show, no refunds will be made. The entire number of nights booked on the hotel booking form and confirmed by K.I.T. Group will be charged.

No-shows will be released at 09.00 the following day, and the accommodation will not be refunded.

Cancellation of the Conference

In the event that the conference cannot be held or is postponed due to events beyond the control of K.I.T. Group (force majeure) or due to events which are not attributable to wrongful intent or gross negligence of the conference organizers, the conference organizers cannot be held liable by attendees for any damages, costs, or losses incurred, such as transportation costs, accommodation costs, financial losses, etc.



Data Protection

1. Processing of Credit Card Details

When you book your hotel accommodation you will be asked to complete the online form providing your full name, address, email address and telephone number. The collected information is required to process, book and complete your booking (including the sending of a confirmation email of the booking to you).

Should you choose to make the payment for your booking by credit card, your credit card details (i.e. credit card type and number, CVC code, expiration date, credit card holder name) will also be collected.

All data will be saved and processed in compliance with the applicable data protection legislation.

In order to protect and safeguard the personal data provided to K.I.T. Group, appropriate business systems and procedures have been implemented and are in full operation. For example, credit card information is transmitted through a secure server protocol, which encrypts all personal and credit card details. The encryption method used is the industry standard "Transport Layer Security (TLS)" technology. The TLS certificate for K.I.T. Group and all its subsidiaries has been issued by utn.usertrust.com

Furthermore, security procedures and technical and physical restrictions for accessing and using personal information have been implemented and are in full operation. Only authorized personnel are permitted to access personal information for performing their duties in respect of the requested services.

The server and network of K.I.T. Group and all its subsidiaries are protected by firewalls against unauthorized access. Intrusion detection systems that monitor and detect unauthorized attempts to access or misuse our servers are installed and in full operation. Your credit card details will be kept by K.I.T. Group for up to three months after the end of the Conference.

2. Sharing of Contact Details

The acquisition, handling (which includes saving data, changes, transmission, blocking and erasing) and utilization of all personal data is executed by K.I.T. Group within the applicable guidelines of the effective German data protection regulations / European General Data Protection Regulation.

K.I.T. Group will collect and store all data for the preparation and execution of the World Confederation for Physical Therapy Congress 2019. In addition, K.I.T. Group and its subsidiaries periodically share contact details of attendees with third parties (e.g. industry companies) that may use these details to contact attendees regarding activities at the Conference or other communications which may be of interest. Therefore data might be passed on to third parties (e.g. industry companies) unless otherwise explicitly indicated by the attendee. Your complete contact details will only be forwarded if:

- your explicit consent is given, or
- a third party has proven to K.I.T. Group that you have violated the rights of this third party and thus demands the disclosure of your data as long as your interests, fundamental rights and basic freedoms are not outweighed, which is required by the protection of your personal data, or
- K.I.T. Group is obliged to give out your data due to, for example, a court order or an official order.

Liability

K.I.T. Group shall be held liable in the framework of a duty of care as a respectable businessman according to statutory provisions. The liability of the conference organiser - for whatever legal reason - shall be limited to intent and gross negligence. The liability of commissioned service providers shall remain unaffected by this. The attendee shall take part in the conference at his/her own risk. Oral agreements shall not be binding if these have not been confirmed in writing by the conference organiser.

Fulfilment and Jurisdiction

This contract is subject to the law of Berlin, Germany. The terms of this contract shall be fulfilled in Geneva, Switzerland and in the event of any legal claims arising from either party; Berlin, Germany shall be the sole court of jurisdiction.

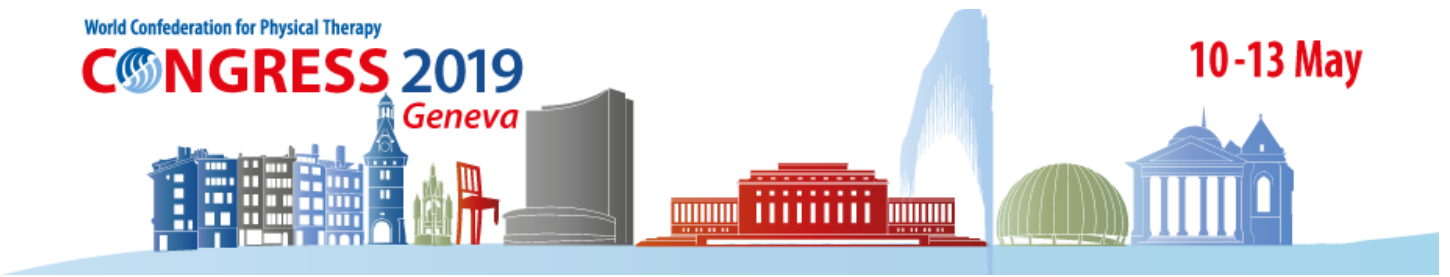
Severability Clause
